

AVASWC, AVASWM, AVASW - History
By Paul Burton, MSW

The following is a history of the Association of VA Social Workers, and its prior names and configurations.

1979

At this time in the VA there was no e-mail, no FORUM, no Outlook, and no computers or DHCP/VISTA. The personal computer had not been invented yet (PC in 1981, the Mac in 1984). Approval by the Director and/or Chief, MAS was required to send a fax. There were telephones. FTS (Federal Telecommunication System), a national telephone system for federal agencies, was the dominant method of system wide communication. The VA was the Veterans Administration, a freestanding federal agency that reported to Congress and the President. The term "VA Headquarters" (HQ) did not exist. In 1979 it was called VA Central Office (VACO). VA facilities were termed VAH (VA Hospital), VAD (VA Domiciliary) or VA OPC (VA Outpatient Clinic). VA hospitals were in the process of being renamed VA Medical Centers (VAMC). There were VA Medical Districts, loosely organized offices with limited authority that monitored budgets, transferred funds, and aspired to achieve some consistency between the VA facilities in the District. Each district had a Director, who was also a director of a VA facility in the district. The District Director position was a collateral assignment. There were no healthcare systems, networks, etc., as we know them today.

July - At a VA District 25 Social Work Chiefs meeting at the Brentwood VAH there was a discussion on the need, feasibility, and purpose of a professional association for social work chiefs. The name "Association of VA Social Work Chiefs (AVASWC)" was agreed upon. Paul Burton was elected Chairperson, AVASWC Committee, and agreed to poll the VA social work chiefs to determine interest. Subsequent activity originated from Paul Burton's home. The District 25 social work chiefs became the "Formation Committee", or steering committee. They were:

Paul Burton's wife, Roxanne, organized a mailing list from a variety of documents and typed each social work chief's address on 3 x 5 cards. The technology was primitive by today's standards. Announcements, membership forms, and newsletters were produced with a typewriter. Mailed documents were addressed with a typewriter, or addresses were handwritten.

September - An announcement and a dues notice form were mailed to all 171 social work chiefs. Interest in forming an association was expressed by filling out the form and sending one's dues. The dues were arbitrarily set at \$10.00 per year to pay for printing, copying, and mailing expenses.

The first person to join was Hector Negron, Chief, Social Work Service, San Juan, Puerto Rico. Dues were promptly received from 75 social work chiefs. There was nationwide support for, and debate about, the association. However, some adamantly opposed it. They made phone calls and wrote letters to Paul Burton, and to VA Central Office staff, expressing concern that an independent association would circumvent the line of authority in the VA. Paul Burton responded by saying that was the idea. The issue was debated on two or three social work hotline calls (conference calls). Central Office staff, including Carlton Engquist, Director, and Dave Anderson, Deputy Director, Social Work Service, supported the association in principle, but believed it would be a conflict of interest for Central Office social work staff to join. However, Dave Anderson reversed his initial position and joined the association, surprising many (including Carlton Engquist). Some of the social work chiefs who had opposed forming an association then joined.

October - On 10-9-79 the first association newsletter was mailed (before there was officially an association), with a form to nominate officers and another membership form to join the association.

November - 10 more dues forms and checks were received with nominations for officers, bringing the membership to 85. There were members in each of the 25 VA Medical Districts and in 40 states plus Puerto Rico.

1980

January - The second newsletter was dated 1/12/80. It was mailed with a ballot to elect officers and an “interim treasurer’s report” which showed the expenses to date in forming the Association. No one had been nominated for Secretary or Treasurer, so the newsletter called for nominations for those positions.

March - The third newsletter was mailed 3/30/80. The first officers were announced and began their term of office. They were:

President - Paul Burton (Sepulveda, CA)
Vice President/President Elect - Shirley Courson (Baltimore, MD)
Newsletter Editor - Dorothy Geary (Long Beach, CA)

The call for nominations for Treasurer and Secretary in the January newsletter generated several nominated candidates and several write-in candidates. A ballot for Secretary and Treasurer was mailed with the March newsletter.

April - Joe Armstrong (Coatesville, PA) was elected Secretary and Jean Richardson (Lyons, NJ) was elected Treasurer. That completed the slate of elected officers.

June 1980 – John Fulton, a member of the original steering committee, was selected to succeed Carlton Enquist as the Director, Social Work Service, VACO. Dave Anderson, Deputy Director, who believed he should be Director, appealed John’s selection, delaying John’s appointment about one year. John remained a member throughout his tenure as VA Social Work Director, and often called on the Association to support current issues in the VA.

July 1980 – Paul Burton visited the IRS office in Van Nuys, CA, to find out about establishing AVASWC as a non-profit, tax exempt, organization. The IRS advised that the Charter & By-Laws had to be renamed “Constitution” to qualify AVASWC as a non-profit, tax exempt, organization. The by-laws were promptly renamed “Constitution & By-Laws”. That was satisfactory to the IRS and Paul was told the organization could declare itself a non-profit, tax exempt, organization.

Although the by-laws called for an election in August 1980, none was held. The housekeeping chores in setting up the new association took precedence. It became clear that a nominating committee was needed to find potential elected officers from among the membership.

1981

In the absence of an election in August 1980, the original elected officers continued to serve. They were:

1982

Shirley Courson became President in August 1982. She called for an immediate election to get the Association back on the schedule outlined in the By-Laws. Some changes were made in the offices of the executive committee. The Secretary and Treasurer positions were combined. These changes were approved by the membership in the same election that elected new officers.

November - Officers elected:

It was proposed to change the tour of office to two years, and to add the position of Past President to the Executive Committee. Lee King, President, felt that one year was too short and created lack of continuity in the elected leadership. He also wanted to change his tour from 10/1/84 through 9/30/85 to 1/1/85 through 12/31/85

1985

There was much activity, re-writing the Constitution & Bylaws, debate about the terms of office, etc.

February – Just as new officers were becoming knowledgeable and effective after the first few months of their terms a new election was held. Two-year terms were thought to be more effective in achieving continuity and stability of the elected officers. Lee King, President, proposed a change in the by-laws. An election was held (ballots mailed) and the membership voted to change the by-laws. The elected officers would thereafter serve two-year terms. The terms remained from October 1st to September 30th. The position of Past President was added to the officers/executive committee. The office of President became a six-year commitment, two years as Vice President/President Elect, two years as President, and two years as Past President.

1986

During this period of change, no election of officers was held. The previously elected officers continued to serve. Lee King initiated several conference calls. There was debate about whether the FTS phone system should be used by the Association. The debate occurred on conference calls using the FTS phone system. The executive committee decided ultimately to continue using the VA phone system for Association conference calls.

1988

The previously elected officers continued to serve. There was little activity

1989

September 1989 – At a national VA social work chiefs' meeting at the Federal Mining Academy, Beckley, West Virginia, Helen Kapiloff approached Paul Burton and asked, "Whatever happened to that social work chiefs' association"? Paul replied, "I don't know, I haven't heard much about it lately". Helen asked, "Well, who is responsible"? Paul replied, "You're the President". After Helen recovered from her surprise, and regained her memory, she asked Paul Burton to be the Newsletter Editor. She asked Jerry Satterwhite to be the Nominations Chair. Jerry and Helen found people to be candidates for office. This all occurred in about 30 minutes.

November - An election was held. Jerry Satterwhite agreed to collect the ballots.

In addition to the candidates listed on the ballot, there were 17 write-in candidates for various positions. Their names were retained by Jean Richardson as possible candidates for future elections. Also on the ballot there was a proposal to establish an association of VA social workers (majority voted “no”), and an item to send the Newsletter to all SW Chiefs, both members and non-members (majority “no”).

During his first year as President, Jerry, while attending a meeting in DC, went to Capitol Hill to present interests on behalf of VA social workers to be included in the Hybrid Title 38 series. He visited with staffers from Senator John D. Rockefeller and Daniel K. Inouye’s offices. This was the first attempt to connect with members of Congress to present issues of interest and concern to the Association.

In September 1993, a conference of VA social work chiefs was held at San Antonio, Texas. During the conference, there was a meeting of the Association. The majority present voted to change the name of the Association from the Association of VA Social Work Chiefs to the Association of VA Social Work Managers (AVASWM). The VA was being reorganized (Dr. Kizer’s Prescription for Change), and many facilities were abolishing or restructuring chief’s positions. The title “Chief” no longer applied to several of the members, although they remained in managerial positions.

Suzanne Demong, Treasurer, learned the IRS rules for non-profit organizations had changed. She began the paperwork, completing a nine page form, to establish AVASWM as a non-profit under the new rules. The IRS wanted proof of the organization’s existence and history. Newsletters, ballots, correspondence, the original Constitution & By-Laws, a letter from Paul Burton describing the beginnings and history of the Association, a copy of a letter to Paul Burton from Dave Anderson, Deputy Director, VACO Social Work Service, offering congratulations on the formation of AVASWC, and a financial accounting for the years 1991 through 1993, were collected and submitted to the IRS.

June 3, 1994 – John Fulton, Director, Social Work Service, retired. Thereafter a series of acting directors (or no directors) were responsible for VA social work leadership.

In a letter dated May 17, 1995, from the District Director, IRS, to Suzanne Demong, Treasurer, the Association was formally notified that it was classified as a non-profit, tax exempt, organization under Section 501(a) of the Internal Revenue Code. The specific Internal Revenue Code section under 501(a) that applies to AVASW is 501(c)(6) for membership organizations. Occasional reports to the IRS have been required, and have been completed by the Treasurer, since then.

Through private experts/consultants an AVASW web page was constructed, named - vasocialworkers.org.

Development of the web page led to the need for a logo. A contest was held with a \$50 cash prize and a Dreamland t-shirt for the designer of a logo approved by the Executive Committee. John Forest, a social worker at the Washington DC VA, developed (or found) the circle/ribbon concept. Judy Arnold, Leavenworth, KS, came up with the "VA Social Workers: The Human Touch in Healthcare" wording. Danny Coker (Medical Media, Birmingham) put it all together in its present form in a graphics file that could be used for letterhead, merchandise, etc. John Forest and Judy Arnold shared the cash prize, each receiving \$25, and each received a Dreamland t-shirt, for designing the Association logo. The logo was then adopted by VACO Social Work Service and was used on the VA Social Work Service website.

September – VA Social Work Chiefs Conference, Tropicana Hotel, Las Vegas, Nevada: An open meeting of the Association was held. In addition to the reports by the officers, there was discussion about the Association's role in pushing for a GS-12 clinical social worker position. Paul Burton gave a report on efforts that started in 1991/1992, shortly after licensure for VA social workers became required by Federal Law. In short, OPM said it was possible with existing classification standards and it was up to the agency. The agency, VA Personnel Svc., said it was not possible because of the classification standards, which were obsolete (published in 1967).

2000 – During January, Jerry Satterwhite and President Elect Judith Talbert went to Washington DC to meet with VA officials, and educate Congress on behalf of the Association. Unfortunately, the “Blizzard of 2000” hit the DC area, Central Office was closed down, and they were stranded at Sandy Brake's house. Fortunately, Dave Dempsey, NASW, was able to track them down and arranged a meeting with Congressman Rodriquez, TX. He had recently introduced legislation to create a Nation Center for Social Work Research. It was agreed the Association would attempt to get co-sponsors for the legislation.

Jill Manske resigned as President when she was selected Director, Social Work Svc., VA HQ, effective 8/13/00. Larry Peterson, Vice President/President Elect, assumed office as President. Mike Juvenal, Newsletter Editor, announced his retirement as of 9/30/00. Joe Pugliese, Nominations, resigned the Nominations Chair.

Due to the promotion of Jill Manske, and the retirement and resignation of some officers, an election was held at the AVASWM open meeting on 9/13/00 at the VA SW Mgrs. Conference, Frontier Hotel, Las Vegas, NV. A new Vice-President/President Elect, Nominations Chair, and Newsletter Editor were elected. The officers, previously and newly elected, were:

The members present also voted to change the Constitution/By-Laws of the Association and open membership to any VA social worker, a significant change in the membership of the Association. The association was renamed the Association of VA Social Workers (AVASW). These changes required revision of the Constitution/Bylaws of the organization. Maureen Shafer and Judith Talbert agreed to form a sub-committee to revise the Constitution/Bylaws.

2001

January – Newsletter mailed. April – Newsletter mailed, with revised January newsletter, ballot for bylaws changes, and ballot for election of three Association members to the Social Work Leadership Council.

Social Work Leadership Council – The SWLC was a group of field leaders that had been formed to consult with the Acting Director, Social Work Service. In her new role as Director, Social Work Service, Jill Manske expanded the SWLC. She appointed the AVASW President to the SWLC. She invited AVASW to select three representatives to serve on the SWLC. The chairs of the standing social work committees and three members at large appointed by Jill Manske were also on the SWLC. The Congressional Liaison was also added to the Executive Committee of the Association and added to the SWLC as a consultant. That totaled five AVASW representatives on the SWLC. The Executive Committee decided the best way to select member representatives on the SWLC was to have them elected by the membership. It was further decided that the SWLC representatives would be voting members of the AVASW Executive Committee as they would be voting members of the SWLC. Changes in the Bylaws were proposed to reflect that decision.

The Constitution & Bylaws changes were approved by the members. The AVASW members elected to the VA Social Work Leadership Council were:

After the Association meeting, President Larry Peterson and Congressional Liaison Jerry Satterwhite spent the day in Central Office visiting with the Undersecretary for Health as well as representatives from Mental Health, Rehabilitation, Extended Care, Primary Care, and the Director of Social Work. During their visits, they explained the purpose and makeup of the Association and expressed support for the Social Work Professional Practice Directive.

In November 2002, Susan Barfoot, Treasurer, announced she could no longer continue to serve due to excessive workload demands. March 11 & 12, 2003, Judith Talbert and Jerry Satterwhite traveled to Washington DC to educate Congress about VA social work issues, meeting with staffers from the House and Senate Veterans Affairs Health Sub Committees, as well as Senators from their respective states (Ohio and Alabama). A primary purpose of the visits was to seek legislative support for social workers inclusion in Hybrid Title 38.

They day after they left, staffers from the Senate Committee on Veterans Affairs, chaired by Senator Arlen Specter (R-Penn) called VACO for information about Hybrid Title 38. This permitted VACO to communicate directly with Congress. Previous proposals for Hybrid Title 38 had been impounded in the Office of Management & Budget and never made it for review by any congressional committee.

5-23-03 - Senator Arlen Specter (R-Penn) Chair, Senate Committee on Veterans Affairs, introduced Senate Bill 1156, which proposed to move social work (and other professions) from the Title 5 personnel system to Hybrid Title 38. The details were to be implemented at the discretion of the Secretary.

The bill passed the Senate and House, and was signed into law by President Bush on 12-6-03, becoming Public Law 108-170, Veterans Health Care, Capital Asset and Business Improvement Act of 2003. A task force was immediately assembled in VACO to begin implementing the law. In the final form 22 occupations or professions were included.

SB 1156 was initiated and supported by the Association of VA Social Workers. This will change significantly, and positively, the personnel management for social work in the VA

The terms of the Social Work Leadership Council members elected by the Association expired in June 2003. A special election was held to elect new representatives, to re-elect the Secretary whose term was to expire in September 2003, and to elect a Treasurer (Susan Barfoot's term would have also expired in September 2003 and Paul Burton's interim term expired accordingly).

Due to Jill Manske's public relations efforts and description of AVASW at national social work conferences (USSW & NASW) she received inquiries about how to start a social work association. One inquiry was from Lt. Cmdr. Carol Jones, MSW, BCD, a naval officer stationed at Bethesda Naval Hospital and another from Ms. Nelson, MSW, a social worker employed by HSS. Both inquiries were forwarded to Paul Burton, as one of the founders of AVASW. Ms. Jones was interested in forming an Association of Military Social Workers and Ms. Nelson was exploring the feasibility of forming an Association of Federal Social Workers. E-mails were exchanged between Paul Burton and the inquirers from the Navy and HSS. Unlike the VA, neither the military nor HSS had a centralized register or list of social workers or social work leaders, making communication with potential members of either a military or a federal social work association difficult. The Navy had no centralized social work authority. Apparently no social work associations resulted from the inquiries.

May 17, 2007 - Doug Mitchell, President, testified before the Senate Committee on Veterans Affairs at the confirmation hearing for Dr. Michael Kussman, candidate for VA Undersecretary for Health. This is the first time the Association has been asked to participate in the confirmation of a top VA official. It was the result of Jill Manske, Director, Social Work Svc., VACO, listing the Association, and Doug, as references to the Senate regarding Dr. Kussman's confirmation. The Senate Committee on Veterans Affairs staff members then contacted Doug Mitchell requesting him to testify. He agreed.

Dr. Kussman was Acting Undersecretary since 8-12-06 and Deputy Undersecretary since 5-29-05. He came to the VA from the Army where he retired as a Brigadier General. He supported efforts to make the transition from military to civilian life more effective, particularly with transfers from military medical to VA medical programs. He was endorsed by the Association. May 30, 2007 – Dr. Kussman is confirmed and officially appointed Undersecretary for Health.

May 30, 2007 – Jill Manske, MSW, LISW, Director, Social Work Service, VACO, retired after 32 years of government service. Her retirement was announced shortly before she left and was a surprise to many. Ms. Manske distinguished herself and social work during her tenure in VACO. She was a past President of AVASW and supporter of AVASW as Director, Social Work Service.

June 2007 – elections of new officers are held. Rocco Bagala and William Lanning are elected AVASW representatives to the SWLC. Isreal Jones is elected Newsletter Editor. Galen Britain is elected Secretary. A change in location of the website occurs and Kate Buike agrees to become the website manager (webmaster). Israel Jones resigned as Newsletter editor due to workload pressures. Cody Frasure, President, nominated Jana O’Leary to become interim Newsletter Editor, which was approved by the Executive Committee in the spring 2008. Sandra Dunn resigned as Vice President/President Elect also due to workload pressures. Judy Arnold was elected to replace her.

A major reorganization occurred in VACO, starting in 2007, with the formation of a new Strategic Health Group called the Office of Care Coordination and Social Work. Kristin Day, former Deputy Director, Social Work Service was appointed Chief Consultant for the new Health Group. Carol Sheets was selected as the Director, Social Work Service, and will report to Kristin. Kristin determined the Social Work Leadership Council (SWLC) had become too large and unwieldy. 2010

Community Service Project – A check for \$1000.00 was sent to the Fisher House Foundation 1-15-10 by IW McKinney, Treasurer. A thank you letter was received from the Fisher House Foundation in return.

Internet Services – The Executive Committee explored methods for automating and updating membership records. IW McKinney, Treasurer, contacted active members for whom no e-mail address was listed in the membership records. Barbara Fretwell, Web Manager, investigated various companies and various means of using the AVASW website as the focal point for maintaining membership records. Her successful efforts allow people to join or renew memberships on line paying dues with credit cards. The prior method of mailing dues payment checks to the Treasurer still exists. However, members are encouraged to use the automated system. Paul Burton, Member At Large, sent e-mail messages and letters to former members advising them of the changes and inviting them to re-join AVASW. Due to the efforts of Barbara Fretwell Web Manager, AVASW moved from a paper system to an electronic system with the following changes:

Dues can be paid online via Pay Pal with payments automatically posted to the member database, Wild Apricot

Members can access their member records online and make changes or adjustments.

Members receive automated notices letting them know when their membership is due for renewal.

Email notices can be sent to the membership notifying them when nominations for elected officers are open, inviting nominations for an organization for an AVASW financial donation, and when changes are made to the website that would be of general interest.

Elections and surveys can be completed electronically using Survey Monkey with results automatically tabulated. Electronic voting includes election of officers, and voting for an organization to receive a financial donation.

May – I.W. McKinney announced his planned retirement and his intent to resign as Treasurer. Judy Arnold appointed Paul Burton Interim Treasurer, which became official on the May 13 AVASW Executive Committee conference call. The transfer of duties and the initial transfer of AVASW funds were completed by May 24. The final transfer of funds was completed June 26.

September – Since the business year of AVASW was changed to the calendar year instead of the Federal fiscal year, the terms of the elected officers were extended to Dec 31st by vote of the Executive Committee. Jana O’Leary, Newsletter Editor, announced her resignation. The Constitution & Bylaws were reviewed and revised, approved by the Executive Committee, and published on the AVASW website. In addition to some minor revisions an important change made the appointed members of the Executive Committee voting members. They previously did not have a vote.

In September and October announcements and solicitations for candidates for the elected positions of Treasurer, Member at Large – Retired, and Nominations Chair were sent to the membership. Included in the announcements was an invitation to apply for Newsletter Editor, a position appointed by the President.

Jerry is also a member of the Hall of Fame, and his significant contributions to AVASW and VA Social Work are well known. After some discussion about the wording, the Exec Committee approved the proposal on 10-23-10. The first inductee under the new name was Alex Bealer. Alex received his plaque on 11-18-10.

November/December – Elections were held with for Treasurer, Nominations and Member at Large. Jana O’Leary resigned as Newsletter Editor. Natalie Weathers applied for Newsletter Editor and was appointed. The Executive Committee members as of January 2011 are:

The **Council on Social Work Education** (CSWE) assembled a task force to develop standards for social work graduate schools to include in their curricula services to military personnel, veterans, and their families. Cody Frasure, AVASW Past President, and Judy Arnold, AVASW President, served on the task force. From VACO Carol Sheets, SW Director, and Debra Amdur, Chief Consultant, Care Management and Social Work, also served on the task force. The task force guidelines and final report were published 8-6-10.

2011
The website, automated membership records, ability to pay dues online, and treasury accounting were all operational and in place at the start of 2011. Adjustments and updates were periodically made.

6-3-11 - Judy Arnold, President, retired from the VA. At Judy’s request, Miguel Ortega, Vice President/President Elect, replaced her as the AVASW representative on the VACO Social Work Leadership Council.
